3. NGUC will retain 40% of the item(s) sale price as commission.

8. Consignor agrees to return to NGUC within 10 business days of contract end date to pick up all unsold merchandise. Consignor acknowledges that pick up is only available during set days/times and will make arrangements with NGUC to find a suitable pick up day/time. Any merchandise not picked up within 10 business days will be donated to churches or charities in Murray, Kentucky. If consignor authorizes NGUC to automatically donate unsold items, items will not be held for pickup and will be donated immediately after contract end date.
